

Strategic Incentives

Property Tax Exemptions

- Up to 5-year property tax exemption
 - Additional 5 years available for agricultural processors or a project located in property leased from a governmental entity
 - May negotiate a fixed or graduated rate over 20 years in lieu of property taxes
 - No personal property, which includes equipment inventory, materials in process, and accounts receivable

Corporate Tax Exemptions

- Five-year corporate income tax
 - Wage & Salary and Research credits available

Sales Tax Exemptions

 Sales and use tax exemptions on manufacturing equipment, water, electricity, interstate communications, and computer and telecommunications equipment for technology-based businesses

Financial Incentives

- North Dakota Development Fund gap financing loan and equity program
- PACE program interest buy down program at Bank of North Dakota
- Match Program some of the lowest interest rates in the nation for "A" rated companies

Job Training Programs

- One-stop job training assistance both state and federal programs available for businesses
- Workforce 2000 state-funded program for training new technologies and processes
- North Dakota New Jobs Training Program "no cost" program utilizing employee withholding tax

Competitive Business Costs (cont.)

Real Estate/Facilities

(weighted averages for Fargo, ND, according to 2005 SIOR Comparative Statistics)

- Rent/lease
 - \$13.00-\$18.00/sf to rent quality office space
 - \$3.55-\$5.00/sf to rent industrial space
- Construction \$37.00/sf to build 40,000 sf industrial facility
- Sales
 - \$50.00-\$125.00/sf to purchase office space
 - \$37.00-\$50.00/sf to purchase industrial space

Public Policy

- Access to public officials unequaled
- Constitutionally balanced budget no major deficits
- Only state-owned bank in the nation offers business expansion funds

Taxes

- Ten-year tax analysis recently completed by third-party accounting firm comparing property, corporate, and sales taxes along with workers compensation and unemployment insurance cost across 11 states and communities
 - ND #1 in lowest taxes for manufacturing facility
 - ND #1 in lowest taxes for food processing facility
- #6 in nation for best location in terms of overall costs of doing business (2003 Business Facilities Magazine)
- 2003 State Legislature lowered top corporate income tax rate from 10.5% to 7%

Education and Quality Workforce

Primary

- 13.3 to 1 student to teacher ratio (NEA 2003)
- Fourth graders ranked in top 10 in math and top 20 in reading (NAEP 2003)
- Eighth graders #2 in math and #4 in reading (NAEP 2003)

Secondary

- #1 for highest public high school graduation rate (84.1%, compared to 66.1% for the U.S. - 2000)
- #1 in SAT Test Scores (2002)

Post Secondary

- #1 in college continuation rate for high school graduates (69.4%, compared to 56.7% for the U.S. average – 2000)
