


North Dakota manufacturers come out on top

An independent analysis proved North Dakota has lower business taxes than 10 other states. Eide Bailly, an accounting and consulting firm with offices in eight states, conducted the analysis as if it were research for a new medical device company. The firm evaluated the 10-year tax costs for a new, 66,000 square foot manufacturing facility to include land and building costs, an expansion, equipment costs, as well as employment and sales growth.

Research was conducted in December of 2002 for all applicable tax scenarios, including incentives, for five tax areas:

- Property taxes
- · State and local sales tax
- · Corporate income tax
- · Workers compensation insurance
- · Unemployment insurance

North Dakota has worked diligently to provide incentives that assist new and expanding businesses in the critical first five-to-ten years of operation so these companies become profitable sooner. The state's strategy has paid off with tax advantages that surpass the other states reviewed in this analysis (see below).







- In lieu of a property tax exemption in full or part, negotiate a fixed or graduated property tax rate for up to 20 years
- Corporate income tax exemption of up to five years for new or expanding manufacturers
- Wage and salary corporate income tax credit for new businesses
- Income tax credit for research expenditures
- Sales and use tax exemption for manufacturing equipment, water and electricity
- No personal property tax including equipment, inventory, materials in process and accounts receivable
- Lowest workers' compensation premium rates in the nation


