ND WOWS DEVELOPMENT PROFESSIONALS AT SEATTLE RECEPTION

North Dakota hosted a fabulous reception for the Industrial Development Research Council Congress in May — the first reception we've offered for that group.

The IDRC is comprised of corporate real estate and development professionals from around the world, vendors and service providers to professionals, and other states competing with North Dakota.

The organization, which meets twice yearly, held its Spring Congress in Seattle. North Dakota Gov. John Hoeven and Lewis and Clark's guide, Sakakawea, were the biggest attractions at the reception, held at the Seattle Sheraton Towers Hotel. Even though three other states hosted events at the same time, North Dakota attracted 600 of the 1,700 Congress attendees.

It's unusual for a governor to be present, and Gov. Hoeven's interest and knowledge made an impression on our guests. Sakakawea was featured on invitations and signs, as an ice sculpture, and as a reception gift on a chain or in a velvet case.

Co-sponsors for the reception included Montana-Dakota Utilities, the Bismarck-Mandan Development Association, the Minot Area Development Corporation, the Fargo-Cass County Development Corporation, and the Grand Forks Area Development Corporation.

ED&F CO-SPONSORS MAJOR DEVELOPMENT EVENTS IN WILLISTON

Hundreds of developers eager to learn about foodproduction and IT opportunities in North Dakota are expected to participate in the Fourth Annual Ag Open (Aug. 7-9) and the Second Annual IT Open (Sept. 11-13) this year.

The events, held in Williston, will each feature several days of networking activities, business tours, golf at the Red Mike course, and boating or fishing.

The Ag Open is expected to draw 250 participants. At the event, processors from across the US gather in an informal setting to learn about opportunities to secure crops and build plants in northwest North Dakota and northeast Montana. The event is co-sponsored by ED&F, development groups from North Dakota and Montana, financial institutions from Iowa to Washington, Burlington Northern Santa Fe Railroad, and many vendors to the dry land and irrigation industry from the northern plains and Pacific northwest.

Last year's First Annual IT Open attracted about 175 information technology-related participants, and many more are expected this year. The event gives attendees a chance to relax and network while they explore the benefits of moving or expanding their business to North Dakota. ED&F and the Williston Area Development Corporation are co-sponsors. Last year, participants included information technology companies from out-of-state, as well as North Dakota companies ranging in size from the largest (Microsoft/Great Plains) to small start-ups.
